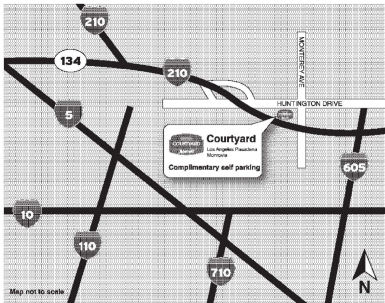
Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.
