Hanna, Trustee, David William Hanna Trust dated October 30, 1989.
- 6. On September 10, 2010, Tim J. Morgan, Trustee of Hanna Annuity Trust dated 6/5/2008 (the "Annuity Trust"), distributed all shares of Class B Common Stock held by the Annuity Trust, of which 37,152 shares were distibuted to Tim J. Morgan, Trustee of David W. Hanna Children's Trust dated 6/5/08, of which 33,769 of such shares were sold on December 13, 2010.
